Why did China reduce the export duty on photovoltaic products?

Then,with effect from the November 2024 announcement,China decided to reduce the export duty on photovoltaic (PV) products from 13% to 9%. Effective December 1,2024,the reforms reflect China's efforts to reform its business and tax policies.

What is the new tax rebate rate for photovoltaic products?

In a joint statement issued by the Ministry of Finance and the State Taxation Administration,it was revealed that the export tax rebate rate for photovoltaic products,along with batteries and certain non-metallic mineral products,will be reduced from 13% to 9%.

In 2012, China introduced a new export tax policy aimed at reforming incentives for manufacturers, including the solar industry. In 2012, however, the government began gradually reducing these exemptions to bring them into line with international trade standards and to address concerns about unfair trade practices
